VICE-PRESIDENT: Kristi Helfen, NCTM

Registration is now open for our fall conference at Piedmont University, November 4-6. You can access the portal for online registration by visiting https://georgiamta.org/conference-register.php. As an added bonus, all attendees who register for the full conference will also receive a complimentary Friday night banquet ticket. Highlights for this year include: Pedagogy Headliner, Martha Hilley, who has some great topics in store for us that you'll be able to read about in our next newsletter; Conference Recitalist, Jasmin Arakawa, performing a solo piano concert on Friday night with works by Johann Christian Bach, Beethoven, Chopin, Faure, Florence Price, and Joshua Uzoigwe, and holding a master class on Saturday morning; and Commissioned Composer Garrison Gerard's piece titled "Evaporating Echoes" scored for flute, clarinet,

violin, cello, and piano to be performed on Thursday afternoon after the business meeting.

We have 14 session presenters, all from Georgia, with two sessions held concurrently in 45-minute time blocks. On Thursday evening we will hear our GMTA concerto audition winners with the added treat of a performance by Dr. James D, Mellichamp, President of Piedmont University, on the school's Sewell organ which houses some 3,691 pipes. Dr. Mellichamp holds a Doctor of Music degree and has appeared in concert throughout the US, Canada, Europe, and Asia. And, of, course, there will be multiple opportunities to hear our student performers. Lots of other information is available on our website, including conference lodging (Hampton Inn in Cornelia, Georgia), program advertisement, and vendor exhibiting. Regarding meal options, a boxed lunch is available on Friday with two menu choices, and requests will be honored for those with dietary restrictions.

Following the successful implementation of our Spring 2021 GMTA State Auditions via a virtual modality, we look towards planning for a hybrid implementation this year. Regional auditions will take place virtually through video submissions while our State auditions will take place in-person at Piedmont University on April 22-23, 2022. Local auditions will be at the discretion of Local associations, but we believe a number will opt for in-person auditions.

Deadlines:

February 28, 2022: Deadline to Register for Regional Auditions. Local Audition ratings due. GATE scores due.

March 19, 2022: GMTA Regional Auditions Video Submission Deadline

March 21, 2022: Registration Deadline for GMTA State Auditions

VICE-PRESIDENT, MTNA COMPETITIONS: Christina Toole

This year's state and southern division MTNA competitions will take place online. Applications will be on the MTNA website in the next week or two; the application deadline is September 15th at 3:00 pm. Please visit the MTNA site for full competition guidelines.

After registering through the MTNA website, students will receive guidelines from GMTA for uploading video. These video submission guidelines will be emailed by September 30th.

The video upload deadline is October 16th and judging will take place by October 24th.

EXECUTIVE DIRECTOR: Mandy Reynolds

Each person will be emailed a copy of the 2020-2021 GMTA Financial Summary and the 2020-2021 Financial Statement from Haley & Associates.

(2020-2021 GMTA Financial Summary) The 2020-2021 GMTA Financial Summary lists the income and expenses for this fiscal year. The second column lists the actual amounts at the end of June 2021. Our total income was \$63,128.80. Our total expenses were \$59,509.75. This left us with a net surplus of \$3,619.05. The primary reasons for the

surplus were no hospitality/location fees for GMTA Auditions, less travel expenses for the GMTA President, and no student travel grants since the MTNA Competitions were held virtually. The third column lists the budgeted amounts for 2020-2021, and the last column compares our revenues and expenses for the 2020-2021 fiscal year to the 2019-2020 fiscal year. Beginning at the top of the second page, there are the explanations for the miscellaneous income and expenses. The balances are also listed for our checking account, savings account, and four named award funds.

(2020-2021 Financial Report from Haley & Associates) At the end of each fiscal year, GMTA hires a CPA firm, Haley & Associates, to complete an Accountant's Compilation Report. During July of 2021, GMTA worked with Haley & Associates to provide information for this year's Compilation Report, which has been submitted for your review.

The "Comparative Statement of Financial Position" for June 30, 2021 shows GMTA's total assets as \$129,440 and total liabilities of \$9,978. The total liabilities represent prepaid GMTA dues received prior to July 1, 2021 for the 2021-2022 fiscal year. The last column on this page details last year's assets and liabilities.

The second page of the report titled "Comparative Statements of Activities" details income and expenses for fiscal years ending in 2021 and 2020. This report does detail 'non-cash' items such as depreciation on office equipment. This page also details GMTA's Student Award Funds. Net assets at the end of the 2021 fiscal year were \$119,462, compared to \$119,307 in 2020.

The third page of the report titled "Comparative Statements of Cash Flows" details the increases and decreases in cash flow for the years ending in 2021 and 2020. At the end of our 2021 fiscal year, we have \$127,995 total in our bank accounts (including checking, savings, and named award funds).

REPORTS of COMMITTEE CHAIRS

ART AWARENESS & ADVOCACY: Debra Hughes

- 1. As AA&A Chair I submitted a request for our upcoming Conference to invite a local official to make some sort of presentation since MTNA encourages us to do that. It was decided that with so many different variables this year that perhaps next year it might be done more easily.
- 2. I sent Grant guidelines directly to various GMTA members in the hopes that funding might be able to be received for their non-profit music projects. The Grant information will be included in our upcoming newsletter. Unfortunately, the announcements for these Grants come out only about a month before they are due and the paper work is substantial so many are unable to apply so quickly. But perhaps by receiving the information now might give those interested a forewarning so that in the following year they might be able to take advantage of them more readily.
- 3. The Georgia's Own was updated last fall with only two participants making some verbiage changes to their directory listing. There were no additional members joining Georgia's Own this past year.

CERTIFICATION: Robin Engleman

As of July 31, 2021, GMTA has a membership of 431 and of those, 85 are nationally certified. As of June 30, 2021, the end of our last fiscal year, we had a membership of 564 and of those, 89 were nationally certified.

Congratulations are in store for Tracy Xian, of Columbus GA, for the successful completion of all requirements for MTNA National Certification in Piano. Tracy has a doctoral degree in piano performance and a minor in piano pedagogy. She is an Adjunct Professor of Piano at LaGrange College where she teaches applied and class piano. She is also a collaborative pianist at Schwob School of Music at Columbus State University. Tracy has been teaching at her private piano studio for 11 years. She is GMTA College Faculty Chair and the President of Columbus MTA. Finally, she has been a church pianist for 29 years.

There are a couple things I would like to work toward during the rest of my term:

1) work with Tracy, our fearless GMTA College Faculty Chair, toward encouraging noncertified college faculty members to consider MTNA certification.

2) encourage any local associations which currently do not offer any type of compensation toward the cost of a member's national certification to consider assistance.

Finally, I encourage you, if you are not nationally certified, to explore the possibility of becoming certified, either by doing the Teacher Profile Projects or through Administrative Verification. Here's the link to get you started:

COMMISSIONING: Jeri-Mae Astolfi

- a) A call for applications for the 2022 GMTA Commissioned Composer Award was issued in May (with subsequent follow-up reminders) to all GMTA members, state-wide colleges/universities, and various national composer organizations. The application deadline is September 1.
- b) The commissioned work from GMTA's 2021 Commissioned Composer, Garrison Gerard, was received and disseminated to the performers on June 1st. An interview with the composer will appear in the GMTA Fall Newsletter prior to the premiere performance on Nov. 5, 2021, at the GMTA Conference at Piedmont University.
- c) Seeking to strengthen relations and interest between composers and GMTA, GMTA Commissioned Composer Award committee member, David Peoples, produced a successful pilot of a hiking piano concert (July 12, Don Carter State Park) via the NEGMTA Chapter. Upon approval from GMTA, Peoples has graciously agreed to

transform this into a statewide GMTA venture. There is no cost to GMTA and the submission process is open to any composer, including GMTA members, students of GMTA members, and composers nationwide.

FINANCES/ADVISORY COMMITTEE: Joy Poole

The GMTA Finance and Advisory Committee met on July 20[,] 2021 via Zoom. Members attending were Jan Adams, Kristi Helfen, Mandy Reynolds, Cathy Thacker and Joy Poole.

Amounts of the awards for each fund were decided. The FAC will present two action items concerning award funds for executive board approval.

- An award for MTNA Competitions Sr. Piano funded by the Broadhurst Award Fund
- An award for MTNA Competitions Sr. Brass, Woodwind, Vocal and Strings funded by the GMTA General Award Fund

Kristi Helfen, VP of Programs gave a report for the upcoming conference details including conference banquet, boxed lunches and covid protocols. GMTA members will follow the health protocols set forth by the host college, Piedmont, for the 2021 conference.

GMTA will end 2020-21 with a surplus. The FAC members decided to wait until Spring to allocate these funds.

President Jan Adams appointed an ad hoc committee to study the process of students advancing through the levels of Auditions. Members are: Huu Mai, Mason Conklin, Rebekah Boles and Joy Poole.

A second ad hoc committee to study the structure of GMTA Theory and GATE was also created. Members will be appointed by Jan Adams.
