PRESIDENT: Jan Adams, NCTM

GMTA has 577 members; 88 certified teachers and 7 Collegiate Chapters.

We had another Covid outbreak in January which led to many continuing to hold Local Association events virtually. The EB voted to bypass the GATE Theory until conditions were more favorable for testing. Even with the January scare, many Local Associations held their Local Auditions in person. The State Auditions were held April 22-23, 2022 at Piedmont University. Huu Mai, VP/Auditions and his team of Regional and State Coordinators worked tirelessly to make this a successful event for our teachers and students.

In March I attended Division and State meetings for the MTNA Conference. We were all disappointed that another conference has been cancelled due to Covid. The 2023 MTNA conference will be held in Reno, Nevada. The dates are March 25-29, 2023. Hopefully, it will be in person. I want to extend a thank you to all of our members who voted for the Southern Division Director. Our very own Joy Poole is now the Director-Elect for MTNA Southern Division! Congratulations, Joy!

VICE-PRESIDENT, PROGRAMS: Kristi Helfen, NCTM

The 2022 Fall Conference will be held on November 3-5. We've been in discussion with Kennesaw State University since early January about being our host. The director of the School of Music has agreed to the terms of the contract, and it is now in the hands of the KSU Board. We are hoping to hear any day now that they have approved it.

Our Conference Recitalist is pianist Paul Barnes, Professor of Music at the University of Nebraska. Barnes has served as Conference Artist at several MTNA State Conventions and has been named Teacher of the Year by the Nebraska MTA. He has also been featured seven times on APR's Performance Today and on the cover of *Clavier Magazine*. *New York Times* says his playing displays a "Lisztian thunder with deft fluidity" and *Grammophone Magazine* describes him as "a shining soloist". He has collaborated with Phillip Glass on many projects, but has agreed to perform a wide variety of composers on his recital for us. A special thanks to Cathy Thacker on her recommendation of Mr. Barnes!

Composer, Pianist, and Educator Wynn-Anne Rossi is our Pedagogy Headliner. Rossi has a vibrant educational outreach to audiences across the US and around the world. With over 150 publications, her focus has been mostly on compositions for piano, but she has also written vocal works, chamber music, and pieces for concert band and orchestra. As a presenter, she's known for her innovative lectures and workshops on a wide variety of subjects. Many of her compositions have been included in the National Federation of Music Club's Festival Bulletins. Her two most popular series are *Musica Latina* and *Jazzin'Americana*.

So far, we have received about 28 proposals for presentations at the Conference. May 1 is the deadline for submittals. About 12-14 proposals will be accepted.

VICE-PRESIDENT, MEMERSHIP: Beibei Lin

As of 4/26/2022, GMTA has 577 members. In 2022 thus far, we have gained 63 new members.

The GMTA Podcast, which began in August 2021, currently has 33 episodes. Our listeners come from all over the US as well as other countries including Canada, Germany, Belgium, France, Republic of Korea, Kenya, Pakistan, Mexico, Russia, among others. On average, each episode receives 57 listens, though some are more widely shared and listened to than others.

(April 25, 2022 Financial Summary: attached at end of minutes) The 2021-2022 GMTA Financial Summary lists the income and expenses for this fiscal year as of April 25, 2022. The second column lists the actual amounts on April 25. Our total income so far is \$71,550.08. Our total expenses so far this year are \$62,758.75. The third column lists the projected income/expenses for the end of the fiscal year. Items in red font are expected to change in amounts from now until June 30. The fourth column lists the budgeted amounts for 2021-2022, and the last column compares our revenues and expenses as of April 25, 2022 to March 31, 2021. On the second page, there are the explanations for the

miscellaneous income and expenses. At the bottom of the page, the balances are listed for our checking account and savings account. The savings account also includes our four named award funds. The balance for each award fund is also listed.

REPORTS of COMMITTEE CHAIRS:

ART AWARENESS & ADVOCACY: Debra Hughes, NCTM

- 1. As AA&A Chair I requested for a notice of a free March advocacy event be sent to all of our membership. Usually this event National Arts Action Summit costs money and is live but new national guidelines made it available for free & virtual this year. Unfortunately, GMTA was not able to send the notice out except to Presidents. (NOTE: GMTA sends emails to the membership through Constant Contact since we have too many members to send through Gmail. Unfortunately, there is no way to forward emails through Constant Contact. The information was emailed to the local association presidents who were asked to forward it to their members.) Usually, the notifications for these type of forums from Georgians for the Arts come to me with a very short lead time which is difficult for us as an organization to broadcast. BUT more importantly, here are some of the reasons why GMTA members should attend such gatherings:
- a. Learn the latest research facts and figures on the arts to help make a case for support.
 - b. Strategize with experienced advocates on how to make the case for the arts and arts education.
 - c. Connect with our members of Congress and build a relationship that will lead to better
 - d. representation for the arts at the federal level.
 - e. Network with fellow arts advocates from across the country and get connected with your Federal Arts Advocacy Chair to learn about year-round advocacy opportunities.
- 2. The NEA (National Endowment for the Arts) offers many grants for individuals and organizations, as well. GMTA does a very worthy service in Georgia and is deserving of

additional support that may be available. Being informed is an important first step. Membership via email is so easily accessible that I encourage that we begin by having every member of GMTA to sign up for email notices from the NEA which is free. Perhaps each member of the Executive Board might start the trend.

- 3. The Georgia's Own was updated this past fall with only two participants making some verbiage changes to their directory listing. There were no additional members who joined Georgia's Own this past year.
- 4. I've requested that GMTA ask a local official from the site of our November conference to be included in some way in the conference like introducing an event or speak briefly. This is an action recommended by MTNA for us to increase advocacy in civic circles. It is being considered but details have yet to be finalized with the location before a person can be approached.

WELLNESS: Debra Dickensheets

COVID -19 hit hard this winter with the Omicron strain, but cases steadily decreased through the spring and now are low in Georgia. Fortunately, serious illness and hospitalizations are especially decreased vs before, so overall we all have a sigh of relief that this pandemic is winding down and we can get back to normal. As of May 1, however, there has been an uptick in cases of COVID - 19 in some areas of the US and in Georgia, too. This reminds us that appropriate precautions and preventive measures should still be kept in mind. Although masking is now not routinely done in most public settings, there are still situations where wearing a mask is advised. Please keep in mind that if a person has symptoms of possible COVID - 19, a positive test, or an exposure to COVID - 19, a mask is advised until the situation is resolved. Many people will choose to wear a mask based on personal preference, after reviewing their own level of risk and of those around them. Vaccines, even with current strains of COVID -19 in circulation, do help prevent serious infection and hospitalization. Doing a booster in addition to the primary vaccine series enhances immunity. Our current improved community level status in the pandemic is due to improved overall immunity in the population, due to both natural infection and vaccines. It is not too late to be vaccinated! At this point, vaccines are available for children 5 or older, but not yet authorized by the FDA for less than 5 years. For that young age group, it is important that those around those children are vaccinated and taking precautions to prevent transmission of COVID – 19 illness. We fortunately now have oral antiviral medications (such as Paxlovid) that can treat COVID – 19 illness in those at risk for more serious disease. Everyone is encouraged to be tested if they are ill and suspect COVID – 19 infection, and, if positive, quarantine and consider calling their doctor to see if they are an appropriate candidate for treatment.

NEW BUSINESS

- 1) Approval of 2022-2024 GMTA Executive Board: President-Elect Cathy Thacker. Vote passed 100%
- 2) Approval of 2022-2023 Budget. No discussion. Cathy Thacker motioned to approve. Vote passed 100%

FAC ACTION ITEMS

1. FAC Proposal:

GMTA Theory Testing be expanded to more levels.

The Primer Level will be added first, and the current levels will be reconfigured. The ultimate goal is that there will be a total of 13 levels (Primer, plus 1-12), which will loosely correspond to grade levels. However, teachers do not have to enter a student at the same level which corresponds to the student's grade level. In other words, a 1st grader could be eligible to take a Level 3 GMTA Theory Test.

Quite a bit of discussion. Joy Poole tabled the motion and no vote was taken.

2. FAC Proposal:

GATE be expanded from three to four levels: A, B, C, and D.

A – Grades 4-5 B – Grades 6-8 C - Grades 9-10 D – Grades 11-12

There was a motion to amend this proposal. The voting on the amendment passed with a 90% vote. Cathy Thacker proposed that the changes to GATE would begin for the 2024-2025 school year.

3. FAC Proposal:

Proposes that exemptions from mandatory GATE testing will be available in the same school year as when the student passes the GMTA Theory Test.

A friendly amendment was made: "for students who submit by December 1st" will be added to this proposal. This proposal passed by the majority

4. FAC Proposal:

Deadline for GATE/GMTA Theory/Local Auditions will be January 15th. Fall

Deadline: October 1st

This proposal passed by the majority

5. FAC Proposal:

Change the judging process from assigning ratings (OP, AE, HM) to a ranking system.

- Judges would rank each student from top performer to lowest. Example: 18 students in Grade 4 – Judge would rank students from 1-18
- Auditions VP would assign the ratings as specified in audition guidelines

This proposal is referring state level auditions. The motion was tabled by Joy Poole.
