Instrumental, voice and college level piano events took place on Friday, April 14, and all precollege piano events took place on Saturday, April 15. Winner results will be posted by April 22. We received much complimentary feedback from the judges about how well-organized the Auditions were.

Several of us from GMTA enjoyed attending the MTNA conference in person, held in Reno, Nevada. Georgia was well-represented with two presentations. Dr. Vicente Della Tonia, Jr., reprised his session about Five-Finger Patterns from the 2022 GMTA Conference in a condensed format. Dr. Grace Huang

from the University of Georgia co-presented with colleagues from Minnesota and Florida. We were a bit under-represented at the Gala and shared a table with Ohio, but we were thrilled to see Joy Poole receive her Foundation Fellow award. Igor Lipinski, the "musician magician" (so named by MTNA CEO Gary Ingle), entertained us with his finesse and piano playing.

The third column lists the budgeted amounts for 2022-2023, and the last column compares our revenues and expenses as of April 18, 2023 to March 31, 2022. On the second page, there are the explanations for the miscellaneous income and expenses. At the bottom of the page, the balances are listed for our checking account and savings account. The savings account also includes our four named award funds. The balance for each award fund is also listed.

## **REPORTS of COMMITTEE CHAIRS:**

## ART AWARENESS & ADVOCACY: Cameron Fuhrman

My first year as the chair for Arts Awareness and Advocacy (AA&A) has been a year of learning. Of course there is significant overlap between arts advocacy and arts awareness. Insofar as they are distinct entities, however, I have different levels of previous knowledge and experience with each. I am relatively familiar and comfortable with the idea of increasing awareness of the arts, particularly at the local level. Arts advocacy, however, is newer territory for me. In my mind, the concept of advocating for a cause conjures images of extroverted, politically-oriented action: politician calling, signature gathering, public speaking...things that sound fairly daunting to me and, I think, to many. Holding the AA&A chair position has given me a great opportunity to dig into the idea of advocacy, exploring the various forms it can take and challenging my rather narrow view of what it can entail.

While the first of my two GMTA newsletter articles for the 2022-2023 school year highlighted a variety of relatively easy-to-implement methods of increasing arts awareness, the second (coming in the May newsletter) will focus on ways individuals and local associations can participate in arts advocacy. These range over quite a broad spectrum: from public advocacy at the state government level to simple consideration of how we speak about the arts in conversation with our students and communities. My aim for this year's newsletter articles has been to make involvement in arts awareness and advocacy feel more doable for those who, like me, may have felt intimidated by the idea in the past or unsure of where to start.

For next school year's AA&A articles in the GMTA newsletters, I hope to focus increasingly on preexisting resources that GMTA members can use to build their own practices of arts awareness and advocacy. Over the course of this past year, I have gradually increased my own knowledge of such resources, subscribing to AA&A-related newsletters and blogs and gathering a list of useful websites/organizations/opportunities our members might enjoy. Honestly, I have been surprised by how hard it is to find such resources, especially those related specifically to advocacy. Most of the wellstructured resources I have found in this domain focus primarily on the visual arts. While we certainly share common goals and, in many cases, a shared rise-and-fall with the visual arts, I'm hoping to discover more music-specific resources. (On that note, if anyone has found good resources, I'd love to hear about them from you!) Expanding my own knowledge in order to be able to present quality ideas in next year's newsletters is one of my summer tasks—along with caring for the the newest little human in our family who is due in a few weeks!

In addition to providing newsletter articles for GMTA, one of my primary tasks is to maintain the Georgia's Own list. I will send out a GMTA-wide email for additions to that list in early summer; I will also check with the people currently on that list to be sure their information is current. We should be able to have the updated list complete by August.

# **CERTIFICATION: Robin Engleman, NCTM**

As of March 31, 2023, GMTA has a membership of 608 and of those, 91 were nationally certified. As of July 31, 2022, GMTA had a membership of 433 and of those, 83 were nationally certified.

The newest GMTA NCTMs are Amaris David (GCMTA), Elena Dorozhkina (AMTA & DMTA), Yingzhou Hu (AMTA) and Graceanne Starr of Hampton, GA (transferred from WI to GA).

Last fall, before the GMTA Conference, I contacted all of the GMTA NCTMs to see how many would like to order a certification pin. I think ended up placing an order for about 12 pins.

We currently have eight teachers in Georgia who have applied to become nationally certified. As far as I know they are all still interested in completing certification. I will be contacting them over the summer for updates.

#### **NEW BUSINESS**

1. FAC PROPOSAL: The FAC recommends that for up to 4 hours of judging, compensation will be \$200; \$50 per hour after 4 hours (per day).

4 hr. up to 4 hr. 59 minutes = \$250; 5 hr. up to 5 hrs. 59 minutes = \$300; 6 hr. up to 6 hr. 59 minutes = \$350; 7 hr. up to 7 hr. 59 minutes = \$400; 8+ hours = \$450

Proposal passes.

FAC PROPOSAL: The FAC recommends that for the Composition Competition the judge will
receive \$25 per composition with a minimum of \$50. This is in accordance to MTNA
guidelines.

Proposal passes.

3. FAC PROPOSAL: Regions for Pre-College Piano Auditions will be re-organized as follows:

Region I – Gwinnett. Northeast GA, Savannah

Region II - Athens, Augusta, Coweta-Fayette, Golden Isles

Region III - Columbus, Macon, North DeKalb, South GA, South Metro Atlanta

Region IV – Atlanta, Decatur, North Fulton

Region V – Cherokee, Cobb, Rome, West GA

This restructuring moves North DeKalb from Region I to Region III, Savannah from Region II to Region I, and Coweta-Fayette from Region III to Region II. The purpose is to even out the numbers at Regional Auditions and allow more students to advance to State Auditions.

Proposal passes.

4. FAC PROPOSAL: The FAC proposes that the current system of recognizing 75% of entrants in State Auditions be increased to 100%, with the same distribution of 1/3 receiving Outstanding Performer, 1/3 receiving Award of Excellence, and 1/3 receiving Honorable Mention.

Proposal passes.

5. FAC PROPOSAL: The FAC proposes that the registration fee for GATE be increased from \$10 to \$15 to match the registration fee for the GMTA Theory Test. (The fee increase will help cover Auditions-related costs.)

Proposal passes.

6. FAC PROPOSAL: The FAC proposes that Cathy Thacker appoint an ad hoc committee to research adding an area of composition for Elementary through High School students.

Proposal passes.

7. FAC PROPOSAL: The FAC recommends that GMTA charge the following prices for exhibitor space at the GMTA Conference:

\$125 for Table space/display (no change); the charge for Piano space will be \$175 pending approval of the host institution and GMTA.

Proposal passes.

8. FAC PROPOSAL: The FAC recommends we raise the conference fee from \$80 to \$90.

Proposal passes.

9. Approval of the 2023-24 Budget – This item was moved to the end of the meeting.

Salary raise for Executive Director Mandy Reynolds from \$25,500 to \$27,000

Budget has been approved.
