### **REPORTS OF OFFICERS**

Together they have appeared on MTV's Total Request Live, NPR's All Things Considered and From the Top, APM's Performance Today, the Cliburn Concert Series, the Gina Bachauer International Piano Festival, and dozens of summer chamber music festivals.

Our students were invited to participate in the Young Composer Competition. The winners should be announced in the next few weeks and winners will have the opportunity to have orchestration lessons with the CSO Director. The GMTA Auditions Concerto winners will be performing with the Carroll Symphony Orchestra and winners of the *Young Composers Competition* will have their compositions performed by the orchestra. The Diamond Piano Method has graciously offered to sponsor a reception that will follow the Symphony concert.

### **Vice-President, Programs: Susan Tusing**

Vice-President Tusing welcomed everyone to today's meeting at Clayton State University.

We are planning a fantastic program of presentations, lectures, and performances for the 2013 GMTA Conference on the campus of the University of West Georgia in Carrollton.

The conference piano pedagogy headliner will be Marvin Blickenstaff. Blickenstaff is known among piano teachers throughout the country for his teaching, lecturing, performing, and publishing. For sixteen summers he was on the

faculty of the International Workshops where he performed and lectured in Canada, Austria, Scotland, Norway, France, and Switzerland. In 1995 and again in 2004, The Registered Piano Teachers of New Zealand sponsored him in concert and workshop tours of that country. The "Marvin Blickenstaff Endowment Fund" was established in his honor by the Music Teachers National Association Foundation, and he was named "Teacher of the Year" by the Indiana MTA. In 2007 the on-line journal Piano Pedagogy Forum published tributes to Mr. Blickenstaff honoring his contribution to piano teaching in America. Also in 2007 he was named Fellow of the Royal Conservatory of Music in Toronto. He was honored in 2009 with MTNA's highest honor, the MTNA Achievement Award. Formerly head of the piano departments at the University of North Carolina/Chapel Hill and Goshen College (IN), he has taught on the faculties of the Westminster Choir College and The College of New Jersey. He serves on the faculty of the New School for Music Study, where he teaches private lessons and directs the PEPS program for advanced students. Blickenstaff is Board President of the Frances Clark Center for Keyboard Pedagogy and is on the Executive Planning Committee of the National Conference on Keyboard Pedagogy.

Piano Duo Anderson and Roe will be our conference recitalists and master class artists. Known for their adrenalized performances, original compositions, and notorious music videos, Greg Anderson and Elizabeth Joy Roe are revolutionizing the piano duo experience for the 21st century. Described as "Fred Astaire and Ginger Rogers transposed from the dance floor to the keyboard" (Southampton Press) and "the intense synchronization of genius" (ThirdCoast Digest), Anderson & Roe aim to make classical music a relevant and powerful force around the world. Their most recent album, When Words Fade (Steinway Label), was released to critical acclaim in 2012 and spent nearly a dozen weeks at the top of the Billboard Classical Charts, while their wildly creative, self-produced music videos have been viewed by millions on YouTube. Highlights of the 2012-13 season include tours in China, Korea, Taiwan, and Singapore, and their orchestral debuts with the Hartford, Lafayette, and Santa Fe symphony orchestras. They have since toured extensively, with notable recitals in Vancouver, Beijing, Seoul, Singapore, Italy, and most major US cities, as well as in nearly every New York City venue imaginable, from Carnegie Hall to children's hospitals. Together they have appeared on MTV's Total Request Live, NPR's All Things Considered and From the Top, APM's Performance Today, the Cliburn Concert Series, the Gina Bachauer International Piano Festival, and dozens of summer chamber music festivals. As the Northwest Reverb recently stated, "[Anderson & Roe] swept the audience into a cheering mass of humanity, making a strong case that playing piano is the most fun thing that two people could ever do together."

Our commissioned composer is Curtis Bryant, who will compose a choral work to be performed by the University of West Georgia Concert Choir. An Atlanta native, Bryant earned his Master of Music Theory from Georgia State University, studying composition with Charles Knox. Bryant's music has received live performances steadily and has been heard across North America and in Europe, Asia and Australia in concerts, music festivals and on radio and television broadcasts, including National Public Radio's *Performance Today*. Composing for virtually all concert media including chamber, choral, opera, art song and orchestra, his music has been praised for being "immediately attractive and accessible, with an emphasis on beauty of sound, simplicity of means, and expression of feeling" (Atlanta Journal and Constitution). Bryant has also composed music for numerous television series and specials including the award winning <u>Portrait of America</u> series produced by Turner Broadcasting and numerous programs produced on Georgia Public Television. He has garnered seven Southern Regional Emmy Award nominations for original music from the National Academy of Television Arts and Sciences (NATAS), and numerous ASCAP Awards from the American Society of Composers, Authors and Publishers.

The 2013 GMTA Concerto Winners and the winners of the 2013 Young Composer Competition will perform with the Carroll Symphony Orchestra on Thursday night, followed by a reception hosted by Diamond Piano Method.

Following Friday evening's concert we will have a Post-Concert Concert and Reception honoring our collegiate members. Music will be provided by Atlanta by Six, an innovative chamber music ensemble performing a unique blend of classical and contemporary compositions. Atlanta by Six is comprised of Atlanta-area professional musicians who regularly perform with the Atlanta Opera, Atlanta Ballet, Carroll Symphony, Georgia Symphony, Asheville Symphony, Huntsville Symphony, and Rome Symphony Orchestras.

I hope to see a large gathering of members for what I know will be an exciting conference. We would love to hear from members who are interested in serving as presiders and welcome and assist the presenters. #### **NEW BUSINESS**

Action Items from the Financial Advisory Committee:

- 1. Motion the FAC proposes to revise the *GMTA Audition Information & Requirements, Piano Section C. 2* with the following (change in italics):
  - i. A single movement from a sonata or suite may count as one piece. Also, several movements, including selections from theme and variations, may be grouped to count as a single piece, when appropriate. Any other

sectional pieces, such as fantasies, must be performed in their entirety. Contemporary pedagogical repertoire is considered "contemporary: regardless of style. *T he MTNA Composer Classification List will be followed to determine the composer's period. If a composer is not on this list, contact the VP/GMTA Auditions. The Composer Classification List may be found on the MTNA website.* Certain transcriptions may be used with the permission of the VP/GMTA Auditions. It is strongly recommended that the same repertoire not be used two years (or more) in a row. Contact the VP/GMTA Auditions regarding repertoire concerns **prior** to submitting the application to the local association or appropriate chair.

This motion was seconded by Debra Hughes and passed.

- 2. Motion The FAC proposes that the 2014 Region Auditions be organized as follows:
  - I: Region I: Gwinnett, North DeKalb, Northeast Georgia
  - II: Region II: Athens, Augusta, Golden Isles, Savannah
  - III: Region III: Columbus, Coweta-Fayette, Macon, South Georgia, South Metro Atlanta
  - IV: Region IV: Atlanta, Decatur, North Fulton
  - V: Region V: Cherokee, Cobb, Greater Marietta, Rome, Western Georgia

This motion was seconded by Betty White and passed.

- 3. From the Finance and Advisory Committee
  - a. Motion: Request to revise the Procedural Manual 2.5.4.5 statement to read, "The GMTA Audition Theory Examination (GATE), once instituted, will be piloted for one year and instituted in the following year. The GATE will be required of auditionees.

This motion passed.

- 4. From the Finance and Advisory Committee
  - a. Motion—It is recommended that the changes suggested in the presented rationale be adopted and published in the *GMTA Audition Information & Requirements, Voice* and will read as follows.

#### **Section C**

#### 1. REPERTOIRE REQUIREMENTS

<u>VOICE:</u> Memorization of all vocal repertoire is required. Broadway selections are not acceptable.

**Grades 9-12**: At least three songs chosen from three or more categories listed below **EXCLUDING Category F**.

**College/Adult**: At least four songs chosen from four or more categories listed below.

NOTE: Lower division entrants may NOT include Category F.

- A. Art Songs written before 1800 sung in English or Italian.
- B. German Lieder sung in German
- C. French Art Songs sung in French
- D. Other Art Songs in Italian, Spanish, or other European languages sung in the

- original language. At the discretion of the vice-President/GMTA Auditions, Scandinavian or Slavic language songs may be performed in English.
- E. 20<sup>th</sup> and 21<sup>st</sup> century Art Songs in English by composers from the United States, Canada, or other Commonwealth nations written for voice and piano
- F. Arias from operas or oratorios

### 2. MORE REPERTOIRE INFORMATION:

It is expected that teachers will choose repertoire suitable to the student's vocal development. Arias that are commonly included in collections of early art songs and arias are acceptable in Category A when they are appropriate to the student's development. In the case of a high school student with extensive training or a similarly advanced lower level college or adult student, some of the lighter arias by Mozart and others may be acceptable at the discretion of the Vice-President/GMTA Auditions. Transpositions will not be allowed. It is strongly recommended that the same repertoire not be used two years (or more) in a row. Contact the Vice-President/GMTA Auditions regarding repertoire concerns **prior** to submitting the application to the local association or appropriate chair.

#### 5. SCORES:

For all auditions, entrants must provide the judge with one copy of the music with measures numbered. Music purchased online may be used when clearly marked as having been legally purchased by the student or accompanied by a competition letter. PHOTOCOPIES AND HANDWRITTEN COPIES ARE PROHIBITED FOR THE JUDGE'S, STUDENT'S, AND ACCOMPANIST'S USE. Accompanists may use reproductions of single pages to facilitate page turns, but the appropriate published score must also be present on the music stand/rack.

Susan Naylor amended the motion to read "music as having been legally purchased or accompanied by a competition letter." The wording will be as follows:

For all auditions, entrants must provide the judge with one copy of the music with measures numbered. Music purchased online may be used when clearly marked as having been legally purchased or accompanied by a competition letter. PHOTOCOPIES AND HANDWRITTEN COPIES ARE PROHIBITED FOR THE JUDGE'S, STUDENT'S, AND ACCOMPANIST'S USE. Accompanists may use reproductions of single pages to facilitate page turns, but the appropriate published score must also be present on the music stand/rack.

Jonathan Klein seconded the motion, which passed.

President McCord presented the agenda amendment as approved by the FAC: In June, Gary Ingle, contacted state presidents with the following news provided by T. Scott Gilligan, MTNA General Counsel:

The Federal Trade Commission ("FTC") has notified MTNA that it has commenced an investigation into whether the MTNA Code of Ethics unlawfully restrains competition among music teachers. Specifically, the FTC has focused on the provision in MTNA's Code of Ethics which provides as follows:

"The teacher shall respect the integrity of other teachers' studios and shall not actively recruit students from another studio."

MTNA has met with FTC attorneys to explain that MTNA's Code of Ethics is voluntary and that MTNA has never enforced the recruitment provision found in the Code of Ethics. We have also raised several other defenses to a possible enforcement action by the FTC. Nevertheless, the FTC continues to pursue this investigation and has submitted a voluminous request for documents from MTNA.

Although MTNA has shown the FTC that MTNA has no history of enforcing the recruitment provision, the FTC alleges that the mere presence of the recruitment provision in MTNA's Code of Ethics may cause affiliated state and local music teacher associations to either enforce the recruitment provision or threaten to enforce it against state and local members. In this regard, the FTC has informed MTNA that this investigation is not confined to MTNA, but includes affiliated state and local music teacher associations that have similar recruitment provisions in their code of ethics or which encourage compliance with the MTNA Code of Ethics. In addition, MTNA has learned that the investigation also includes other national music teacher organizations that have recruitment provisions in their ethical codes.

It is important to note that 26 states were cited in this complaint. Georgia was cited by the FTC noting that the GMTA:

- Web page quotes the MTNA Code of Ethics, the object of investigation
- Bylaws read as follows
  - o Article III. Section 3: Termination of Membership
    - All members of the ASSOCIATION agree to abide by the Music Teachers National Association Code of Ethics. Membership in the ASSOCIATION may be terminated by the member or revoked by the ASSOCIATION as prescribed in the Procedural Manual of the ASSOCIATION or in the governing documents of MTNA.
  - This is interpreted as imposing anti-competitive restrictions on members.

MTNA has responded to the FTC with a revision of the MTNA Code of Ethics which can be found on the MTNA website. It is not clear if the submitted changes will satisfy the concerns of the FTC.

GMTA has responded with the following action:

- Access to the page that quoted the MTNA Code of Ethics is closed.
- A committee of three past presidents was formed to address the issue raised in our Bylaws.
   Committee members are:
  - o Tom Pearsall
  - Martha Thomas
  - o Betty White
- The revisions committee was guided by the Bylaws:
  - ARTICLE XIV: AMENDMENTS
  - These Bylaws may be amended at any meeting of the GEORGIA MUSIC TEACHERS ASSOCIATION, INC. by a two-thirds vote of the active members present and voting. Notice of any intended change (which has been submitted in writing by a Revision Committee and approved by the Finance/Advisory Committee and the Executive Board) shall be made

available to the members at least two weeks prior to the meeting. These Bylaws with any amendments shall be made available to the membership.

- The Revisions Committee has made the following recommendation that has been approved by the FAC. This would involve removing Article III. Section 3 as follows:
  - Article III.Section 3: Termination of Membership
    - All members of the ASSOCIATION agree to abide by the Music Teachers National Association Code of Ethics. Membership in the ASSOCIATION may be terminated by the member or revoked by the ASSOCIATION as prescribed in the Procedural Manual of the ASSOCIATION or in the governing documents of MTNA.

This recommendation should positively address the issues cited by the FTC without changing the common practice and history of GMTA. Once this investigation is completed, GMTA will have the opportunity make appropriate revisions.

Keith DeFoor seconded this motion to amend the GMTA By-Laws, which passed.

Note: Later, wording can be constructed that would not be anti-competitive. Deleting Article III, Section 3 right now could protect GMTA from legal action by the FTC. President-Elect Robin Engleman will send out an email to local associations to remove the Code of Ethics from yearbooks and websites.
