# **REPORTS OF OFFICERS**

### **President: Dawn McCord**

Summer is a planning time for GMTA officers and teachers and 2014 is no exception. A review of Audition procedures and locations has taken place and suggestions and concerns have been discussed in detail. The Finance Advisory

Committee has reviewed the Procedural Manual and is suggesting edits that will accurately reflect GMTA needs and practices. The Federal Trade Commission (FTC) Order has been finalized and two years of discussion and sharing has paid off with Local Associations (LA) responding with Letters of Compliance and requests for extensions. One LA with only three members is discussing how best to move forward as active members of GMTA. As I understand it, some states have not been as proactive as GMTA. We have done well. Because of the FTC Order, all states as well as MTNA will be required to address FTC requirements in publications and General Meetings in the years to come. We are prepared to do so without any negative impact on the work that we do.

Exciting work has gone in to planning for a fabulous conference and information is posted on our website. Georgia's Own will be posted soon as will the schedule of sessions. Members are reminded to make their hotel reservations through the hotel's office. Our Conference Hotel is the Comfort Suites, Morrow and there is contact information on our website that will direct you to taking advantage of the group rate. Susan Tusing and I visited the hotel as they were doing major renovations on the rooms and we found that this will be a great site for us with rooms only \$69 a night. It is important to make the reservation through the local hotel rather than the national chain. A limited number of rooms are blocked for us during the competitions and the conference.

Conference presentations by our colleagues and headliners are intriguing this year with a lot of variety. There is something for everyone and the conference is sure to wow you. The presentations by Georgia's own teachers will impress you. We have used the conference survey to address topics requested by our membership. Richard Goode will be performing and teaching the Master Class. Jennifer Linn will also headline the event with pedagogy interest sessions. Collegiate members will have their lunch meeting to share their plans. Our Commissioned Composer is Sharon Willis who has had commissions throughout the United States and created a wonderful work for voice, piano, and organ. It is a programmed work that is moving as well as superbly crafted. # GMTA Executive Board Report August 23, 2014 Robin Engleman, President-Elect

I am currently overseeing the selection of our GMTA 2014 Teacher of the Year. I believe we have 5 nominees this year!

I have been in contact with Local Association Presidents as needed and have helped to keep the Local Associations webpage up to date. I have continued working on my goal of visiting at least one meeting or event in each GMTA Local Association. To date, I have visited 16 local associations (Athens, Atlanta, Cherokee, Cobb County, Coweta-Fayette, Columbus, Decatur, Greater Marietta, Gwinnett, Macon, North DeKalb, North Fulton, Northeast Georgia, Rome, SMAMTA and Western Georgia). I have plans to visit Augusta in September and hopefully Golden Isles and Savannah this fall.

I hope by the time of the GMTA Executive Board Meeting, I will be able to announce that:

- We have secured locations for the 2015 GMTA Conference (Agnes Scott College, Decatur, GA) and 2015 GMTA/MTNA Competitions (Clayton State University, Morrow, GA). (as of 8/19, Clayton State is secured)
- We have secured locations for all of the 2015 GMTA Regional Auditions facilities. [as of 8/19, 3 are secured (Mercer, Georgia Perimeter and Kennesaw), 2 are not (Brenau and Georgia Regents)]

I have selected most of the Executive Board for the 11/2014-11/2016 term – VPs and Members-At-Large are in place – just a few committee chair positions left to fill.

### Regarding Auditions:

- I assisted Jan Adams, VP Auditions, mostly by helping with hospitality this year.
- To gain a better understanding of the Regional Auditions process, I served as Region IV Coordinator.
- I am VERY interested and will do whatever I can to see that the GATE test is activated.

### Vice-President, Programs: Susan Tusing

Plans for the 2014 GMTA Conference are starting to take shape, and this year's Conference promises to be an exciting one. The Conference will be on the campus of Clayton State University in Morrow, co-hosted by Spivey Hall. We will celebrate GMTA's 60<sup>th</sup> Anniversary, and MTNA President Kenneth J. Christensen and Southern Division Director Marc Hebda will be in attendance.

Internationally –acclaimed pianist Richard Goode will be our Conference Recitalist and Master Class Artist. Richard Goode has been hailed for music-making of tremendous emotional power, depth, and expressiveness, and he has been acknowledged worldwide as one of today's leading interpreters of Classical and Romantic music. A native of New York, Richard Goode studied with Elvira Szigeti and Claude Frank, with Nadie Reisenberg t the Mannes College of Music, and with Rudolf Serkin at the Curtis Institute. He has won many prizes, including the Young Concert Artists Award, First Prize in the Clara Haskil Competition, the Avery Fisher Prize, and a Grammy Award. His remarkable interpretations of Beetoven came to national attention when he played all five concerti with the Baltimore Symphony under David Zinman, and when he performed the complete cycle of sonatas at New York's 92<sup>nd</sup> Street Y and Kansas City's Folly Theater. In addition to his concertizing, Mr. Goode is on the piano faculty of the Mannes College of Music in New York and serves with Mitsuko Uchida as co-Artistic Director of the Marlboro Music School and Festival in Marlboro, Vermont. Mr. Goode records under the Nonesuch label.

Our Pedagogy Headliner will be Jennifer Linn. Ms. Linn is a multi-talented pianist, teacher, composer, arranger, and clinician, and holds the title of Manager-Educational Piano for Hal Leonard Corporation. In addition to her contributions to the Hal Leonard Student Piano Library, her work includes creating and editing the newly released Journey Through the Classics series. Ms. Linn also was the editor and recording artist for the G. Schirmer Performance Editions Clementi: Sonatinas, Op. 36, Kuhlau: Selected Sonatinas, and Schumann: Selections from Album for the Young, Op. 68. Many of her original compositions have been selected for the National Federation of Music Clubs festival list and are frequently recommended in reviews by Clavier Companion and American Music Teacher magazines. Ms. Linn was commissioned to compose a collaborative work for the 2013 MTNA National Conference in Anaheim, California where her trio

Serendipity for piano, flute and horn, was premiered.

Sharon Willis, Chair of the Depatment of Music at Clark Atlanta University, is our commissioned composer. Her compositions include arrangements of spirituals, cantatas, orchestral tone poems, and organ works. Dr. Willis was commissioned by The American Guild of Organists to write an organ suite for the AGO's Chicago Conference in 2006. She has written several operas, both libretti and music. Her first, *The Opera Singer*, focuses on casting obstacles facing African-American singers in the field of opera. For the GMTA Conference, Dr. Willis has composed a programmatic work for organ, piano, and soprano, and the premiere will be performed by Alex Benford, Elena Cholakova, and Jane Redding.

The 2014 GMTA Concerto Winners will perform with the Southern Crescent Symphony Orchestra and Clayton State University Orchestra on Thursday night. The orchestra concert will also feature a concert performance of excerpts of Gilbert and Sullivan's *H.M.S. Pinafore*, sung by members of Clayton State's Music Drama Workshop.

As always, the conference will include several informative sessions by Georgia's Own. The final schedule of Georgia's Own sessions will be available at the August Executive Board meeting.

I look forward to seeing a large gathering of members for what I know will be an inspiring conference. I would love to hear from members who are interested in serving as presiders to welcome and assist the presenters. The competition coordinators are crucial to the success of this event, and I am extremely grateful for the outstanding work they did in last year's competition. Fortunately, they are all returning, and last year's experience should make this year run even more smoothly. Last year, there were 94 total entrants participating. According to state checklists, Georgia had more entrants registered than any other state! Since this year's competition is more centrally located, there could possibly be an even greater number of participants. There will undoubtedly be some amazing performances and the talent level from Georgia promises to be very gratifying to all who promote music through GMTA events.

They had a successful Spring Music Festival, with 19 pre-college piano students participating, on May 17, 2014, as their first outreach event. ## **Theory: Jason Bennett**

GMTA Theory now involves two components: 1) GMTA Theory Tests, a 5-level achievement program that tests both aural and written skills and is available to any student of GMTA members, and 2) GATEs, a 3-level, pass-fail music theory exam consisting of multiple-choice and limited written responses that is required of all piano and piano concerto participants in GMTA Auditions in order to advance past local auditions.

I have appointed the following administrators to oversee the execution each component:

GMTA Theory Test Administrator: Diane Boyd

GATE Administrator: Rebekah Healan

They have agreed to serve a 2-year term (2014-2016) and will be recruiting committee members to assist them. The Theory Chair (Jason Bennett) will serve as an *ex officio* member of both committees.

In response to Robin Engelman's initiative, we are proposing that the GATE pilot year start <u>this</u> year so that the full implementation can begin in the fall of 2015.

The GMTA Theory Tests are on schedule to be mailed to LAPs around the first week in October.

If you know anyone, including yourself, who might be interested in serving on one of these committees, please have them contact either me of the administrators directly.

I addition, remember the purpose of GATE: GMTA has decided that the "best" musicians are those who master multiple aspects of musical knowledge and expression. In short, it is not enough to produce masterful sound on an instrument. Performers must also demonstrate competency (though not mastery) in music theory. There are certainly other areas of music in which the "best" performers should be competent. Adding a theory competency requirement means that GMTA acknowledges the tremendous value and necessity of mastering multiple aspects of music.

   2014 Georgia Auditions Theory Exam (GATE) Proposal
   Preamble:

Major revisions for the GMTA Auditions were approved in 2012 and the performance portion of these revisions was implemented in 2013. Implementation of the Georgia Auditions Theory Exam (GATE) was to begin a year later but was postponed in order to develop effective testing procedures. The curriculum is already in place and available for review on the GMTA website (<a href="https://www.georgiamta.org">www.georgiamta.org</a>). The GMTA GATE and the GMTA Theory Tests have two different objectives and consequently will have separate administrators overseeing them. The GMTA Theory Chair will be in charge of supervising and advising both of these administrative teams. In order to effectively prepare for implementation of the GATE, the timeline has been revised for review and approval.

Rebekah Healan present the new timeline:

# **Proposal:**

**Georgia Auditions Theory Examination (GATE) Implementation** STRUCTURE:

The GATE will have three levels: GATE Level-A (grades 4-6), GATE Level-B (grades 7-8), and GATE Theory Level-C (grades 10-12). The current school grade of the student will determine which GATE level the student will need to pass.

Although these tests roughly parallel the existing GMTA Theory Tests Levels I, II, and III, the tests will have modifications that fous on basic theory foundations and a shorter test-taking time. GATEs are generally easier. GATE Level-A and GATE Level-B exams will be entirely multiple-choice to facilitate grading. GATE Level-C exam will be mostly multiple choice with limited handwritten notation answers. There will be no ear-training component for the GATE, and GATE will **not** take the place of the GMTA Theory Tests that will be offered as a separate GMTA event.

There will be a \$10.00 fee each time a student takes the GATE.

### **IMPLEMENTATION:**

The following will be implemented this year:

Students in grades 10-12 can earn exemptions from taking the GATE Level-C exam by scoring high on Levels! V or V of the existing GMTA Theory Tests. Earning at least an 80 on Level IV or a 75 on Level V on the GMTA Theory Test will exempt students from taking Level-C of the GATE in subsequent years. In short, they must have earned the exemption by the year before it is applied.

### **Proposed Schedule of Georgia Auditions Theory Examination (GATE)**

**August 2014 -** Present the Theory Examination Framework and procedures to LAPs and the Executive Board

**September 2014 -** publicize the Theory Examination Framework through LAPs and direct emails to each GMTA member.

**November 2014 -** Present one or more sessions on the GATE at the 2014 GMTA Annual Conference.

**February/early March 2015** - TRIAL RUN OF THE GATE: All auditionees will be required to take the appropriate GATE level and they will receive scores but it will not be part of the selection process for promotion to 2015 Regional Events.

**2015-2016** - Full implementation of GATE. To be eligible to progress to the Regional Event, all students must earn a given score on the GATE we well as being selected based on their performance.

### 2014-2015

There will be no fee for this GATE test "Trial Run".

A. "Trial Run" is necessary for two main reasons:

- 1) to provide GMTA members with the adequate time and experience to prepare their students for the exam.
  - 2) to ensure the following year's testing process runs smoothly when the GATE will determine eligibility for students wishing to advance on to GMTA regional and state auditions.

The "Trial" 2014-2015 tests will serve to familiarize students and teachers with the content of allow GMTA to find the most efficient way to administer the tests in subsequent years.

It is possible to put the GATE on the website.

Please remember that this year's GATE "Trial Run" Tests will not have any bearing on the eligibility of students for the 2014-2015 GMTA Auditions.

### 2015-2016

There will be two testing dates in the fall of 2015-2016:

- The first testing date will be in the fall with completion by October 31<sup>st</sup>.
   The test will be administered by the actual testing method that GMTA has been able to develop based on the research year of 2014-2015.
- The second testing date will be Saturday afternoon, November 7, 2015, (after the completion of the Conference). This is a testing date for only the students who were unable to take the test on the first date.

<u>Motion:</u> The FAC proposes that the above timeline be approved for implementation of the Georgia Auditions Theory Exam (GATE). Yes, Fall of 2014. This motion passed after discussion. 32 voted in favor of this motion. No votes against.

2014-2015 – Local Associations participate in a test run of the GATE level tests in preparation for full implementation in 2015-2016.

2015-2016 – GATE is fully implemented. There will be two testing dates in the Fall of 2015:

- (4) Teacher of the Year Nominations, Teacher Grants, Steinway Awards: The deadline is the second Monday in September. Nominations and documents will be submitted online at GMTA Member Resources.
- (5) MTNA Local Association of the Year Award applications are submitted on the MTNA website. The deadline is Nov. 1.
- (6) GMTA Website Directory: In case you missed the good news, members can download an up-to-date directory at any time on our website. The information is updated at least twice a month from the MTNA membership database. Members can update contact information through the MTNA website and our information will be updated within two weeks.

- (7) The 2014 GMTA Conference will be November 6-8 at Clayton State University, Morrow, GA. Online Conference registration is available on the GMTA website.
- (8) The next GMTA Executive Board Meeting will be Saturday, 18, April 2015. LAP will meet at 10 AM. Board (LAPs are members of the board) at 11:15 AM, University of Georgia, Athens.
- (9) Robin an email will be coming about a nomination of Martha Thomas to be an MTNA Foundation Fellow. \$1,000 needs to be raised.
- (10) Dawn Donna Trivette Lee has put in her resignation as Executive Director of GMTA. She has served GMTA from 1987 to present date. FAC will meet following this meeting to decide how to proceed. She will work at Northeast Georgia Medical Center as a Trauma Educator.
