### PEDAGOGY: DR NELITA TRUE

Since Nelita True made her debut at age seventeen with the Chicago Symphony in Orchestra Hall and her New York debut with the Juilliard Orchestra in Avery Fisher Hall, her career has taken her to the major cities of Western and Eastern Europe, Indonesia, Korea, Japan, Mexico, Iceland, New Zealand, Brazil, Australia, Canada, and to Hong Kong and Singapore, as well as to all fifty states in America. She was a visiting professor at the St. Petersburg Conservatory in Russia, performing and conducting master classes and has been in the People's Republic of China more than 20 times for recitals and master classes. She has played recitals on French national television and on Australian national radio. Her most recent recital in Boston was cited as one of the "Ten Best Classical Performances of the Year."

Ms. True has been a jury member for the China International Piano Competition (Beijing), the Queen Sonja International Piano Competition (Oslo), the National piano Competition in Brazil, the Horowitz Competition (Kiev), the Concours de Musique in Canada, the PTNA (Tokyo), the Lev Vlassenko Competition in Australia, and the Gina Bachauer, New Orleans, Hilton Head, and William Kapell International Piano Competitions in the U.S.

A Phi Beta Kappa graduate of the University of Michigan as a student of Helen Titus, Ms. True went on to Juilliard to study with Sascha Gorodnitzki, and then earned the DMA with Leon Fleisher at the Peabody Conservatory. In Paris, she studied with Nadia Boulanger on a Fulbright grant. Formerly Distinguished Professor at the University of Maryland, Ms. True is currently Professor of Piano at the Eastman School of Music. Many of her students have won top prizes at national and international competitions, including an unprecedented five First Prizes in national MTNA competitions. Ms. True was awarded the Certificate of Merit by the Alumni Association of the University of Michigan, the Eisenhart Award for Excellence in Teaching at Eastman, the 2002 Achievement Award from the Music Teachers' National Association, the Lifetime Achievement Award in Graduate Teaching from the University of Rochester, and a Lifetime Achievement Award from the National Keyboard Pedagogy Conference (USA).

### CONFERENCE HEADLINER: DR. JULIAN MARTIN

On the Juilliard School faculty since 1999, Julian Martin was the winner of the 1975 Montevideo International Piano Competition as well as the Collaborative Prize at the 1982 Tchaikovsky Competition in Moscow. Martin has toured extensively, including tours of North and South America, Europe, and Asia. He is the founder and artistic director of International Piano Festival of Gijón (Asturias, Spain). Martin has given master classes in Argentina, Colombia, England, Germany, Israel, Japan, Korea, Switzerland, Taiwan, and Venezuela. He has also served on the faculty of the Oberlin Conservatory, 1982-87, and Peabody Institute, 1987-2002.

Mr. Martin is a juror for many international competitions in North America, Colombia and Korea, and was on the awards panel Virtuosi of the Year 2000 in St. Petersburg. He is an original member of the Gilmore Foundation's Selection Committee in Kalamazoo, and is founder and artistic director of Gijón International Piano Festival (Asturias, Spain). He has been guest faculty at the Glenn Gould Professional School (Toronto), the Conservatoire Tibor Varga (Switzerland), and the Banff Centre (Alberta). He has recently given Master Classes in Great Britain, Canada, Colombia, Germany, Korea, Switzerland, Taiwan, Venezuela and Israel.

Dr. Martin will present the Friday evening recital and will be teaching the Master Class on Saturday morning.

### COMMISSIONED COMPOSER: LEE JOHNSON

Lee Johnson, composer and conductor, has conducted and recorded with world class orchestras such as The Russian National Orchestra, The London Symphony Orchestra, The American Rock Orchestra, The Cyberlin Philharmonia, among many others. He has composed six symphonies, numerous chamber works, four musicals, two operas, concerti, choral and vocal works, works for ballet theater, feature and experimental film, and hundreds of works for multimedia and interactive technologies.

"The music of Lee Johnson defines modern classical music by crossing several centuries and integrating styles. His music has charm and beauty, it warms the heart and invigorates the mind. 





Continue to the end of Highland Avenue (.4 mi)



His teachers include Elizabeth Buday (piano), Edward Kilenyi (piano), Peter Spencer (theory), Ralph Tilden (organ), and Robert Steinbauer (piano). DeFoor has been a featured piano soloist with the Southwest Florida Symphony Orchestra and the Charlotte Symphony Orchestra (FL). DeFoor has served as President of the Fort Myers Music Teachers Association and the Northeast Georgia Music Teachers Association and has served as Vice President for MTNA Competitions for the Florida State Music Teachers Association and the Georgia Music Teachers Association. DeFoor has been a presenter consultant for the Georgia Council for the Arts and has served as Piano Division Chair for the Georgia Music Educators Association. DeFoor is an institutional evaluator for the National Association of Schools of Music and the Southern Association of Colleges and Schools. At Young Harris College, DeFoor has led five European Study Tours and one China Study Tour. In addition, DeFoor is the organist at the First United Methodist Church of Union County (Blairsville).

### DAVID D'AMBROSIO | VP PROGRAM



David D'Ambrosio is Director of Piano Instruction/Accompanying at Agnes Scott College in Decatur, Georgia. As a member of the faculty for 20 years he has performed four piano concerti with the Agnes Scott College Community Orchestra and an arrangement of a Rachmaninoff Prelude with Choral accompaniment with the Agnes Scott Collegiate Chorale among many other recitals with vocalists and instrumentalists.

D'Ambrosio graduated from the Juilliard School with a master's degree in piano performance where he was a student of Ania Dorfmann. Highlights of his professional career include touring the United States and Canada with the Norman Luboff Choir as accompanist and solo pianist, performing on numerous concert series in the southeast, including several sponsored by the Pro-Mozart Society of Atlanta, and appearing in chamber ensemble performances with the Atlanta Virtuosi in their annual Hispanic Arts Festival Series. D'Ambrosio has performed as keyboardist with the Atlanta Civic Opera and its Opera Studio, and was a member of an opera ensemble that toured throughout Metro Atlanta schools under the auspices of Young Audiences of Atlanta. He has frequently served as an adjudicator for piano festivals and competitions.

For the past 27 years Mr. D'Ambrosio has served as official staff accompanist of the Southeast Regional Metropolitan Opera Auditions. From 2007-09, Dr. Indergaard was Chair of the Georgia Music Educators Association Piano Division. A native of North Dakota, he has degrees from Minot State College, the University of Wyoming, two artist diplomas from the Freiburg Conservatory of Music in Germany and a Doctor of Musical Arts degree from the Eastman School of Music. Dr. Indergaard was awarded both a Fulbright Scholarship and an Annette Kade Foundation Grant for piano study in Germany. He has performed throughout Germany and in several other European countries. 



GMTA membership – it's more than just numbers, it's people! GMTA members are music teachers who value collaboration with other music teachers. We learn from each other. We draw teaching tips and ideas from each other. We share experiences with each other. We grow as teachers by drawing on others' experiences as well as our own.

In my area, there are many good music teachers. Many are involved in GMTA, and I know them well. I can refer students to them. I can ask them for assistance and share resources with them.

I've heard students play in local competitions who performed extremely well. Then, I hear their teacher's name – and I don't know who they are -never even heard of them. The student was an excellent performer, but, where are these teachers? Why aren't they a part of GMTA? Maybe it's because they've never heard of us! We assume that because we (the teachers) know about GMTA that everyone else must know.

So here are some ideas all current GMTA members should consider doing to help bring good teachers into the organization.

- First, carry a small note pad with you all the time (and pen or pencil) so you can write down information about prospective teachers.
- Second, whenever you happen to hear someone performing in an event, or even at the mall, take the time to find out who their teacher is. If it's someone you don't know, take another moment to find out about that teacher. Contact that teacher personally and let them know that you heard their student perform. Tell them about GMTA and invite them to become a member.
- Third, visit music stores. When you see people looking at music, ask if they are a teacher or a student (if you can't tell). If they are a teacher, tell them the benefits of GMTA and invite them to join. If they are a student, ask about their experiences as a student and ask about their teacher. Get information about their teacher, and give their teacher a call. You have the picture!
- New members to GMTA would be a benefit to the current members. They may have new ideas and resources to share, which would help us become better teachers. Give it a try. I'd love to hear your experiences. Email me when you make a new contact, and I'll follow up with that prospect. Together we can grow the organization for the benefit of all.

We are now in our bi-annual membership campaign. From July 1, 2010 through June 30, 2011, two chapters with the most new members – one for percentage and one for actual numbers – will receive a free registration to the 2011 GMTA Conference. So, let's really work this year to bring in new members. It will pay off in the long run!


