#### Alabama MTA Tornado Recovery/Music Replacement Fund

The recent storms in the south caused great damage, particularly in Alabama. The Alabama Music Teachers Association has established a Tornado Recovery/Music Replacement Fund to assist music teachers and students who have suffered loss. GMTA has contributed \$1,000 to the Alabama MTA Tornado Recovery/Music Replacement Fund.

Many other state and local associations have contributed to this fund, and MTNA, through the MTNA Foundation Fund, will match contributions to the up to \$5,000.

The way in which associations are coming together to provide this important assistance is very impressive and speaks to the spirit of our organizations.

#### **GMTA/MTNA Competitions**

GMTA was very active in the MTNA Competitions. Eighty three students from diverse age groups and performance mediums participated in the MTNA competitions in 2010-2011.

State Level: GMTA had 11 solo winners, one duet winner, one chamber ensemble, and four composition winners at the GMTA/MTNA Competitions at Augusta State University in November.

Southern Division: GMTA hosted the MTNA Southern Division Competitions at Columbus State University in January. At these competitions, GMTA had two solo winners and two composition winners, as well as one alternate and two honorable mentions in performance and composition competitions.

National Competitions: The MTNA National Competitions were held at the MTNA Conference in Milwaukee in March. GMTA had a national winner in these competitions! Liliya Ugay, student of Fred Cohen, won the MTNA Young Artist Composition Competition! Also, Matthew Shipes, student of David Zerkel, placed second in the MTNA Young Artist Brass Performance Competition, and Jasmine Habersham, student of Matthew Hoch, placed third in the MTNA Young Artist Voice Performance Competition. Congratulations for Liliya, Matthew, Jasmine, and their teachers for these outstanding accomplishments!

#### **MTNA Conference**

The 2011 MTNA Conference in Milwaukee was outstanding with wonderful performances, master classes, sessions, and exhibits. A thrill for us Georgians was GMTA Past President Susan Andrews being named an MTNA Fellow at the Conference Gala. Another highlight was the performance of MTNA Young Artist Composition Competition Winner Liliya Ygan's composition "Slipping Dreams." The work for flute, clarinet, bassoon, percussion, piano, two violins, cello, and double bass was conducted by Liliya's teacher, Fred Cohen.

The 2012 MTNA Conference will be in New York City, March 24-28, and the Hilton New York. I encourage you to consider attending MTNA in the 'Big Apple."

- The MTNA Senior Piano Competition will include a separate award for Best Chopin Performance given by the Chopin Foundation of the United States: \$1,000 renewable scholarship
- The MTNA Young Artist Competition will include a separate award for Best Chopin Performance given by the Chopin Foundation of the United States: \$1,500 honorarium plus a performance recital in South Florida

### 2011 GMTA CONFERENCE | NOVEMBER 3-5 COLUMBUS STATE UNIVERSITY

DAVID D'AMBROSIO

Vice President | GMTA Program

A wide array of presentations awaits those who will be attending the 2011 Fall Conference at Columbus State University, November 3-5. We are pleased that Dennis Alexander will present pedagogy sessions. He is one of the world's most prolific and popular composers of educational piano music for students at all levels. Over the years, Mr. Alexander has been a clinician at state and national music teachers conventions. In 2009, he was invited by MTNA to conduct the intermediate level master class at their national convention in Atlanta. One session will explore the musical elements that create convincing performances of romantic repertoire, and another presentation will delve into questions regarding technique, motivation, repertoire, sight-reading, memorization, rhythm and other issues that every teacher must deal with regardless of the level of the student. There will also be an "Alfred Showcase" highlighting new materials from Alfred Publishing Co.

Our conference recitalist and master class headliner is William DeVan of Birmingham-Southern College, where he has been head of the piano faculty since 1980. Mr. DeVan won first prize in the international piano competition "Vianna da Motta" in Lisbon, Portugal in 1975. He has been soloist with the Zagreb Philharmonic, Croatia, and has performed in Australia. Every other year since 1999, he has performed in Paris, France, most recently in January, 2011. In addition, he has appeared in numerous recital appearances in Germany, China, and Taiwan. DeVan now travels throughout the United States giving concerts and piano workshops sponsored by Steinway. In June 2004, he was named "Teacher of the Year" by the Alabama Music Teachers Association at their annual convention. A winner of two Mellon Foundation Grants, he is co-author of Schumann: *Solo Piano Literature*, a comprehensive guide to the works of Robert Schumann.

Melinda Clark is our commissioned composer this year. She is composing an original 4-movement work which will be premiered by Ray and Beth Chenault, duo-organists, during the General Meeting. Currently Melinda serves as Organist and Director of Music and the Arts at North Avenue Presbyterian Church, Atlanta GA. She has been commissioned to write musical works for churches, cabarets, storytellers, and the music track for a video produced by Atlanta-based *Storytime*, *Inc.* The Chenaults' frequent performances throughout the United States and Europe have garnered critical acclaim in numerous reviews, and they have been featured artists at conferences and conventions of the American Guild of Organists, the American Society for Eighteenth-Century Studies, and in Charleston during the Spoleto Festival.

Attendees who are interested in serving as presiders, who welcome and assist the presenters, are encouraged to send an e-mail to <a href="mailto:ddambrosio@agnesscott.edu">ddambrosio@agnesscott.edu</a>. Registration for the conference is required. Indeed, a varied slate of topics will be available for all teachers who attend the Fall Conference. I am looking forward to seeing everyone in Columbus.





#### Susan Andrews Named A 2011 MTNA Fellow

Susan Andrews, NCTM, was named a Foundation Fellow during the 2011 MTNA Conference held in Milwaukee. The presentation was made during the MTNA Foundation Gala on Monday evening, March 28, at which time 30 members from many locations received this prestigious award for distinguished service to the music teaching profession. Fellows receive an attractive MTNA Fellow certificate and pin. New Fellows are prominently recognized on the Foundation Fund website and their names are added to a plaque located at the MTNA National Headquarters.

It was announced at the 2010 GMTA Conference that Susan would receive this award after various members had joined together to raise the required minimum amount of \$1,000.00 needed to designate her for this honor. The announcement was made at the GMTA banquet on Friday evening, November 5, as a surprise to Susan.



Susan is well deserving of this honor and has served GMTA and MTNA in many capacities. She was president of the Georgia Music Teachers Association from 2002-2004. Prior to that, she served as GMTA Secretary, Vice-President/Membership, Certification Secretary, and High School Auditions Chair. She chaired the GMTA Finance/Advisory Committee. Susan held the position of MTNA Southern Division Senior Competition Coordinator for five years and was also Southern Division Monitor Chair. She chaired the MTNA State Affiliate of the Year Committee and served on the MTNA Nominating Committee. Susan is also a past-president of the Gwinnett County (GA) Music Teachers Association and the Greater Atlanta Music Alliance. Susan holds a BM in Piano Performance from the University of Georgia, operates an independent piano studio, and adjudicates frequently.

As of April 2011, a total of \$1,500.00 had been given to the MTNA Foundation Fund in Susan's honor. Because of back surgery, Susan was unable to attend the MTNA Conference in Milwaukee. Aurelia Campbell received the award for her.





#### GMTA Theory Achievement Tests 2010-2011 Results

Now in our third year under the revised curriculum, we are seeing sustained growth and outstanding student performance on the theory tests. I am pleased to report that <u>255 students</u> took the tests this year, 5% more than last year, and of those, <u>169 students</u> (<u>66%)</u> earned a <u>90 or above</u>, with <u>22 students scoring a perfect 100!</u> This is a direct result of GMTA members' continued support of the theory achievement program as well as members preparing their students thoroughly for the tests.

I am especially grateful to the members of the GMTA theory committee who have made such a quick expansion possible: Dr. Priscilla Jefcoat, B.J. Sutherland, Gayle Vann, and Diane Boyd. As with last year, we are planning to have the 2011-2012 tests ready to mail to local associations by August so that you can choose to administer them in both fall and spring.

If you have an interest in becoming certified, I invite you to read the following article from the <a href="https://www.mtnacertification.org">www.mtnacertification.org</a> website.

#### GETTING THE MOST OUT OF CERTIFICATION

The FTD symbol for florists, the Underwriters Laboratory mark and the Good Housekeeping Seal of Approval—these symbols instill public confidence and foster consumer preference because they are associated with quality, dependability and high standards.

The MTNA Professional Certification Program exists to improve the level of professionalism within the music teaching field. It benefits members of the profession itself, as well as the public who interacts with the profession. For the music teaching professional, certification provides prestige, recognition and the potential for student recruitment and increased earning power. For the public, certification helps readily identify competent music teachers in their communities. The designation of Nationally Certified Teacher of Music (NCTM) is given to successful candidates who meet the professional competencies and standards required for MNTA certification. All music teachers actively engaged in the profession are eligible for MTNA Professional Certification.

#### **College Faculty**
